Community Advocacy Program (CAP). This position is for a Bilingual (Spanish) Domestic Violence Response (DVRT) Advocate who will provide immediate outreach to victims of a domestic violence crime. The DVRT is a project of the Community Advocacy Program (CAP) of Center for Domestic Peace (C4DP). The DVRT Advocate is supervised by the CAP Supervisor. The advocate will provide immediate and ongoing support and advocacy for English speaking victims in the community and their children. The program assists victims, one-on-one, with practical, emotional and social needs by means of outreach, safety planning, peer support, advocacy, information on domestic violence, resources and referrals, problem-solving and court accompaniment. This program is funded by the Office of Violence Against Women.

## **PRIMARY JOB RESPONSIBILITIES**

- 1) Make immediate contact with victims of a domestic violence crime to offer support services and advocacy
- 2) Provide victims and their children with crisis intervention counseling, safety planning, emotional and peer support and information about domestic violence
- 3) Assist victims in determining their needs and developing options
- 4) Provide victims with referrals to community and county resources, as needed
- 5) Assess the children's needs and make appropriate referrals, as necessary
- 6) Accompany victims to court hearings; providing transportation, if needed
- 7) Maintain positive working relationships with the District Attorney's office, law enforcement, and other County agencies
- 8) Monitor the batterer's criminal case and assist the women in voicing their needs and concerns within the criminal court system
- 9) Maintain documentation of activity with participant in the program
- 10) Maintain absolute confidentiality regarding police records and communications with participants
- 11) Assist the Program Manager in developing data for evaluation of program outcomes
- 12) Provide outreach to offsite locations
- 13) Follow-up the DVRT calendar daily

## **REQUIREMENTS**

- 1) 2 years' experience providing legal advocacy for domestic violence victims, especially in the criminal justice system OR 3 years related experience, education or training in a related field.
- 2) Previous experience providing direct services to battered women and their children.
- 3) Successful completion of a certified domestic violence counselor training course.
- 4) Understanding of the peer support model and Center for Domestic Peace feminist analysis of domestic violence
- 5) Crisis intervention skills
- 6) Excellent communication skills
- 7) Fluent bilingual in English/Spanish, both verbal and written (preferred)
- 8) Knowledge of community resources
- 9) Computer skills: comfortable with Microsoft Office 2010 suite with ability to learn new software, as needed
- 10) Resourcefulness, flexibility, self-motivation, and ability to inspire enthusiasm and participation.
- 11) Valid driver's license and auto insurance **with** liability minimum of \$100k (per person)/\$300k (per occurrence), and access to a car during working hours
- 12) Flexible work schedule
