It is with great sadness that we are emailing you to postpone the 5th Annual Heart of Napa Awards, scheduled next week on Thursday, March 19. Each year the community looks forward to this event of inspiration and gratitude. With contributions of their time, talent, and resources, the individuals and organizations nominated for the Heart of Napa Awards demonstrate repeatedly that Napa is a community of great leaders that do the right thing.

As a result of the ongoing health concerns from the spread of the coronavirus, as well as the [Governor's announcement](#) last night, we made the tough decision to postpone the event. We will send you updates regarding rescheduling as soon as we have the opportunity to make arrangements.
