- Attend and lead agency meetings including Management Team, staff meetings and group supervision as needed.
- Assist in the development of new programs and initiatives with outside partners, in alignment with the agency's mission and values.
- Leverage relationships at the individual, interagency, and county levels to facilitate the
 effectiveness and reach of Oakes' services and knowledge. Represent the agency during
 meetings with other county and community partners.
- Complete miscellaneous projects as assigned by Clinical Director.
