We have since established a 501(c)3 nonprofit organization and a community partnership with the American Red Cross. Through this partnership, IHAN establishes emergency integrative health clinics during a major disaster in the state of California. IHAN provides the structure and resources needed to provide safe, sustainable, and effective trauma-informed community care through integrative health modalities. Our mission is to transform trauma into resilience for communities impacted by disasters.

Experience in the following fields is highly preferred: trauma-informed care, integrative health, social work, psychology, and community organizing.

- Maintaining safety of volunteers and clients through implementation and enforcement of policies and procedures
- Organization of volunteers through social and web-based campaigns.
