#### **Position Summary:**

Canal Alliance is seeking a Workforce Target Supervisor. The Workforce Target Supervisor focuses on supervision of our workforce Construction, Bus Operator, Latinos in Finance, and CNA programs. The Supervisor provides administrative oversight, instructional leadership, and creates and maintains relationships with our industry partners. The Supervisor is responsible for ensuring all workforce programs deliver the desired outcomes and wage gains for immigrant clients. A successful candidate is passionate believer in the power of education to improve the lives of immigrants and their families. The WF Target Supervisor reports to the Senior Manager of Workforce Development. This is a full-time, exempt position. Candidates should have the ability to work Monday-Friday from 9am-5pm PST, including occasional evenings and Saturdays. This is an in-person role with occasional hybrid opportunities and requires proof of Covid-19 vaccination. Candidates must live in the State of California.

## **Essential Functions:**

- Supervise all target program activities for construction, bus operator, certified nursing assistant, and banking pathways
- Supervision over client enrollment, progression through workforce programs, and workforce placement
- Provide supervision and case management coaching for WF Target Navigator
- Ensure that workforce navigators are using a restorative and client centered approach in offering supportive services
- Supervising strategies for recruitment and for monitoring participants in the program
- Ensure that assessments, placement, and employment verifications are successfully completed by the WF Target Navigator
- Supervise data input in Salesforce and analyze client data
- Oversight over graduation events
- Identify and align apprenticeship opportunities



- Create and maintain relationships with educational partners, industry partners, and community partners
- Coordinate and supervise volunteers in target workforce programs
- Overall support of WF Service Programs as assigned by WF Development Senior Manager
- Other Duties as assigned by Senior Manager

## Requirements

- 1-2 years of supervision experience
- 2-3 years of case management experience and working with underserved populations
- Associate/Bachelor's Degree or 1-2 years experience in workforce development
- Bilingual in Spanish and English (REQUIRED)
- Proficiency in Microsoft Word, Excel and Outlook
- Experience working with Salesforce and/or other CRM (preferred)
